OCA Annual Report 2022-2023 Treasurer's Message



Our reimagined vision for OCA [Re] Connects, endorsed by the OCA Board of Directors in 2019, was put on hold in 2021 and 2022 until we were finally able to return to an in-person event in 2023.

The OCA Annual Conference was held March 30 and 31, 2023 at Mississauga's Living Arts Centre. OCA Conference days are always very busy and full of tremendous opportunities for learning and engagement. The 2023 Conference was no exception.

Overall Conference attendance was the highest in 23 years; clearly demonstrating the desire of the OCA camping community to come together once again in-person following the pandemic.

OCA [Re] Connects saw an overall count of 2,261 delegates attending the Opening Plenary, 3 Mini Keynotes, 61 workshops and 5 Friday Forums (dedicated to specific topics and kindred groups).

In 2023, we celebrated OCA's 90th Anniversary with a number of terrific initiatives, including a video series of vignettes, led by a stellar committee of OCA Honorary Life Members.

We were especially pleased to welcome back our Preferred Vendors to an in-person Exhibitor Show and to celebrate the huge contributions of several outstanding OCA leaders at our annual OCA Awards Evening.

I would like to thank the Archives Committee, Trent University and OCA Members for their continued support of OCA Archives as an invaluable resource of our rich history.


For the past few years, the Archives Committee has focused on four priorities (celebrating, donating, creating and accessing OCA Archives at Trent) with the common goals of enhancing awareness and broadening the involvement of the OCA community in our history and archives collection. In 2023, as opportunities further opened after COVID-19, the Archives Committee was able to resume some of its regular activities. However, recognizing the ongoing financial burden of the pandemic, our objective was also to multi-task and focus on a few projects that helped promote our priorities, all at once, with limited or no funds. In that spirit, these projects included:

- Combining efforts of OCA 90th sub-committee with Archives and Community Engagement for a special
  OCA 90th Anniversary Hub room at OCA ReConnects. The Hub theme, 90 years of Strength & Resilience,
  celebrated nine decades of OCA camps, leaders and their challenges and achievements through
  displays selected from a wealth of OCA archive material, a special 90th video, and capturing current
  stories and reflections from delegates about the past three years of COVID-19. A special thanks to Trent
  Archivist, Karen Suurtamm, the Archives Committee and 90th sub-committee and many delegates who
  contributed to The Hub, video creation, and COVID stories, all of which were donated to Trent Archives.
  The COVID stories will also be the basis for an Archives project to capture and create digital archives for
  Trent in 2024.
- Archives Committee OCA 'storeroom' records donation and visit to Trent thank you to the Archives
   Committee for the hours of sorting through old boxes of OCA office and donated records held at the OCA
   office, which we 'hand delivered' to Trent, followed by an insightful day of research and learning about
   OCA's archive collection and expanding digital repository opportunities at Trent.

## RESEARCH PRESENTATION AT OCA [RE] CONNECTS 2023

In March of 2023, myself (Stephen Fine), along with Victoria Povilaitis, Ph.D., Director of Program Innovation for Tim Hortons Foundation Camps, and Mandi Baker, Ph.D., Brock University, gave a presentation at the OCA [Re] Connects conference. The presentation outlined various ways to approach camp related research and included: logistical support for students, paid support for research assistantships, community engagement agreements, and OCA independent research. The session was well attended, and a lively discussion ensued. The community members of the OCA Educational Research network are committed to advancement and assistance in the pursuit of camp related research. Camp directors should canvas their staff who are currently active as students at the university level to consider the submission of grant proposals or departmental approval in the interest of further research into the variety of options existing within the camp experience and camp settings.

### CCA UPDATE AND RESEARCH WRITING AWARD

As of late September 2023, the CCA continues with its Reorganization and Strategic Planning process. A three-day CCA gathering of PCAs, and Committee Chairs took place in Montreal during this time to collect face-to-face feedback after a year of scheduled Zoom calls. A great deal of alignment both in terms of direction-setting and in dealing with complex issues was achieved. Members of the Research Committee currently remain intact, however, there were no submissions for the CCA/Trent University Research Prize for 2023.

stand this year as Board candidates. We are constantly amazed at the depth of talent, skills, and experiences of each annual slate of potential Board members.



The Government Advocacy Committee has been busy with a number of important topics that have a direct impact on our industry. We have continued to focus our efforts on securing an affordable and easy-to-navigate immigration process for support workers from outside of Canada who are interested in working at overnight camps. This would include, but not be limited to, individuals who want to work as maintenance, kitchen, dining hall and cleaning staff at camp. We met with the Director of the Temporary Foreign Worker program on this matter at the end of August and provided him with some additional requested information. We are waiting to hear back on this matter and we will communicate any significant developments to the membership.

We are also connecting with the Ontario Ministry of Labour's office to see if international staffing agencies that operate in the camping industry in Ontario can be exempt from having to secure a recruiter license. This exemption is in place in Quebec and Manitoba and we will be requesting an exemption on similar grounds.

Our goal for 2024 is to secure an easy-to-navigate and affordable immigration process in place for international support workers working at overnight camps.

The OCA Health Care Committee (HCC) worked diligently to enhance the safety and well-being of campers and staff. Notable accomplishments include a successful partnership with Concussion 360, resulting in the development of camp-specific concussion guidelines for both day and overnight camp settings. Additionally, the committee engaged with the camp community through coffee chats, hosted a Lunch and Learn session on Medication Management at Camp, conducted health center staff online check-ins during the summer, and successfully recruited new members, broadening the expertise and perspectives within the committee.

As we transition into the new year, the OCA Health Care Committee has outlined ambitious goals to further elevate health standards within the camp community. The committee aims to provide enhanced mental health resources, including the evaluation of existing resources, surveying camp staff to determine needs, and expanding resources based on the identified gaps. A Trauma Informed Care Webinar will be hosted to educate camp staff on recognizing and responding to trauma. This event aims to enhance our understanding of how to provide optimal support to both campers and staff during challenging times, especially when they have experienced adversity. The committee will also assess mental health intake processes, working towards the creation of a comprehensive Mental Health Emergency Action Plan. Additionally,

efforts will be directed towards the transition to online camp documentation, involving the use of virtual platforms and electronic documentation. Collaboration with CampBrain and CampMinder will be sought to explore logistics for remote camps gaining online access, and staff will be trained on the benefits and safety highlights of utilizing an electronic documentation system for the Health Center.

This year, we also bid farewell to longstanding and dedicated committee members: Bev Unger, Pearl Pell, and Cheryl Bernknopf. Their invaluable contributions throughout many years of volunteering their time, knowledge, and expertise on the OCA Health Committee have significantly shaped our pursuits. We look forward to honouring their longstanding commitment in the near future and wish them all the best in their future endeavours. The OCA Health Care Committee remains grateful for their lasting impact and contributions to the camp community.

The OCA Health Care Committee looks forward to a year of continued progress, collaboration, and innovation within the OCA.

Dr. Laura Waltman covered Common Illnesses and Injuries at Camp, providing a comprehensive overview.

#### ACCOMPLISHMENTS 2022- 2023




Develop rich outdoor education professional development content for the annual conference and share outdoor education-specific training opportunities happening across the membership.

#### HIGHLIGHTS of 2022-2023

Of the 88 Accreditation visits that were scheduled to take place this year, 84 were completed and four were deferred to 2024. The four deferments were for reasons of internal camp operations.

The amazing team of OCA visitors included 67 wonderful Senior Visitors and 45 fantastic Junior and Introductory Visitors. Additionally, 22 other visitors who had originally been assigned camps to visit were unable to take part in camp visits due to scheduling conflicts.

The committee would like to highlight that the high number of Junior Visitors is likely a harbinger of increased engagement in the OCA in the years to come.

Thank you to the OCA office team, the committee members, our many volunteer visitors, and our member camp representatives whose hard work and dedication to this process make it all possible.

#### GOALS 2023-2024

The online training videos continue to receive great feedback. The committee seeks continued improvement to Standards Visit training by grouping videos by the intended audience. Some videos are more valuable to a camp professional who is new to Standards Accreditation, and some videos may be more appropriate to a camp professional for whom this is not new. The committee looks forward to reviewing the relationship, timelines and mutual goals shared with Standards Review and to working collectively to streamline processes moving forward to ensure an efficient and coherent standards experience for membership.

The committee strives to increase the engagement of those who are at the beginning of their camp careers in Ontario by providing opportunities for them to contribute to the success of other camps by becoming accreditation visitors.

The committee aims to streamline the visitor-camp matching process through a close examination of Ontario's summer travel geography and visitor distribution.
